Characterize the relationship between Mandisa and her employer.





Novel Introduction Worksheet

Cover analysis: The cover is divided horizontally in two parts of nearly equal size by a curved white bar. Chapter 1 Mandisa's lament

Task 1 Mandisa addresses the mother of the victim. Examples: 'My son killed your daughter' (p. 5 line 1). '...I was not surprised that my son killed your daughter' (p. 5 line 22)

Mandisa addresses God. Example: 'God, you know my heart... (p. 7 line 7)

She feels shame 'The cup You've given me is bitter to swallow. The shame.' (p. 7 line 8) or 'People look at me as though I did it' (p. 5 line 2)

She feels anger 'Where was the government the day my son stole our neighbour's hen ...' (p. 6 lines 39-47)

She regrets the murder 'That is not to say I was pleased. It is not right to kill (p. 5 line 23)'. She regrets the circumstances of the murder 'Oh, why did she not stay out? Why did she not stay out (p. 6 line 28)'?

She wails about children in the townships '... these monsters our children have become...' (p. 5 lines 36-38) and accuses the government '... when it has given him nothing at all, all his life' (p. 7 line 6).

She begs for understanding 'But, you have to understand my son' (p. 5 line 24) and she begs for forgiveness 'God, please forgive my son' (p.7 line 11)
